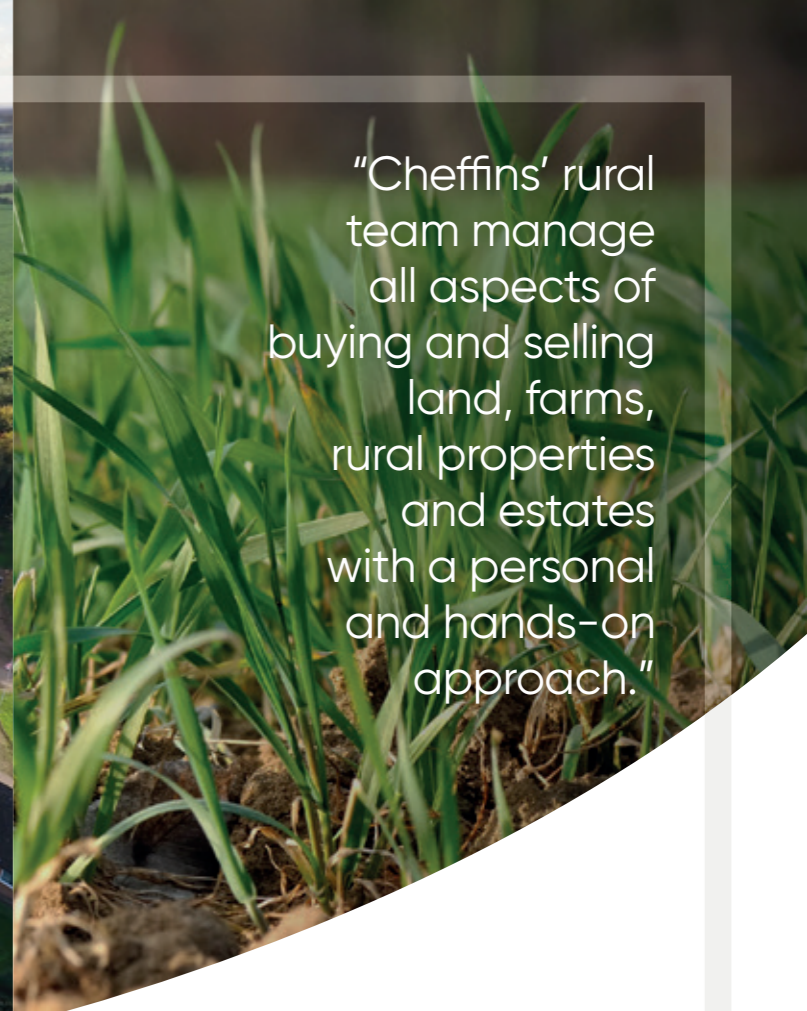

Specialist Rural Services

- Agricultural tenancies (both Agricultural Holdings Act and Farm Business Tenancies) including surrender and regrant, end of tenancy compensation and rent reviews
- Capital taxation including Agricultural and Business Property Relief
- Compulsory Purchase and Development Consent Orders for utilities, road schemes and other infrastructure projects
- Wayleave/Easement negotiations with statutory bodies and private companies for utilities, fibre optic and other service media
- Telecommunication sites including negotiating lease terms and rent reviews under the new Electronic Communications Code
- Energy and Renewables covering advice on lease terms and options for solar, wind and large-scale battery storage schemes
- Conservation Covenants (e.g. for skylark plots, conservation headlands and other biodiversity projects) advising landowners on schemes required by housebuilders and developers to deliver off-site environmental solutions for development schemes.

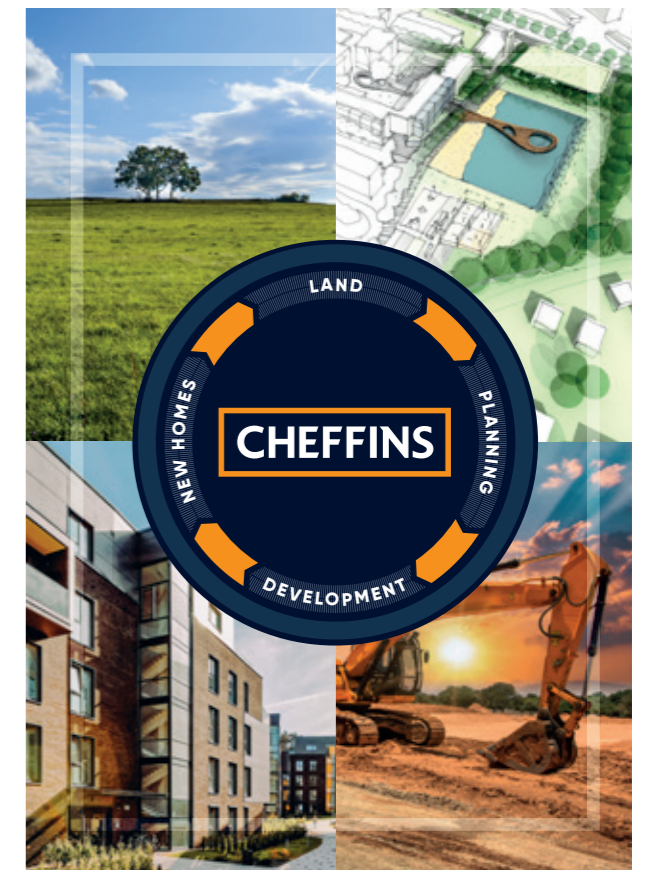
Planning, Development & Strategic Land

We work alongside landowners to unlock the development potential of farm buildings and land utilising a range of options including outright planning applications, option agreements, land promotion, joint ventures and collaboration agreements depending on the landowners' objectives.

Our experienced planners prepare feasibility studies and work with local authorities on a wide range of rural planning matters including new uses for redundant farm buildings, farm diversification projects and removal of agricultural occupancy conditions.

Our planners also regularly submit representations to promote land through local plans and give evidence at public examinations throughout East Anglia.

Cheffins has recently been involved in a number of residential development schemes providing a complete service from negotiation of promotion/development agreements, guiding landowners through the planning application process and handling the successful sale of the land with planning permission. These schemes have ranged from single plots and barn conversions through to large mixed use schemes of 1200+ houses.
